## 1. General provisions

The professional entrance examination for the training of doctors of philosophy during admission to the educational and professional program "German languages and literatures (including translation)" in the field of knowledge 03 Humanities of the speciality 035 Philology is conducted in order to determine the level of specialized knowledge, abilities and skills of entrants.

The professional entrance examination includes an 80-minute exam. (60 min. is provided for written preparation for an oral answer and 20 min. for an oral answer) from the disciplines "Lexicology of the Modern English/German Language", "Theoretical Grammar of the Modern English/German Language", "Theoretical Phonetics of the Modern English/German Language", and "Stylistics of the Modern English/German Language".

# 2. Annotations and typical questions from the subjects brought on the control

An applicant must be able to clearly and linguistically correctly highlight the main stages of the development of such directions of a linguistic science as semantics, pragmatics and cognitive linguistics to explain the theories developed within these directions. The future postgraduate student should be able to compare the positions of various researchers and identify the specific contribution of the most authoritative scientists to the development of the main questions and problems of theoretical grammar, phonetics, lexicology and stylistics. It is necessary to demonstrate the ability to build clearly and accurately one's answer based on written theses and to answer questions quickly asked during the exam.

Each task assumes a detailed answer from a theoretical problem: a statement of the content of the question in all its aspects, with an indication of the problematic nature of the question in general and detailed; formulation and evaluation of views on this issue available in the literature.

In completing the tasks, an applicant must provide a complete, correct answer. The answers must be presented in the form of a well-laid, coherent text that allows an applicant to trace the logic of the reasoning that is the basis of the conclusions drawn.

- 6. Lexical meaning and its types.
- 7. Main directions of meaning change in English/German. Polysemy.
- 8. Synonyms. Typology and characteristic properties in English/German.
- 9. Antonyms. Typology and characteristic properties of antonyms in modern English/German.
- 10. Homonyms in English/German. Typology and characteristic properties.

# Theoretical grammar of modern English/German

- 1. Parts of speech and principles of their selection. Part-language system of the modern English/German language.
- 2. Methods of studying grammatical phenomena in German studies.

- 3. Part-language characteristics of modern English/German nouns.
- 4. Part-language characteristics of modern English/German adjectives.
- 5. Morphological categories of the verb in the modern English/German language.
- 6. Non-finite verbs in modern English/German.
- 7. Service parts of speech in modern English/German.
- 8. Sentence as a unit of communication. Structural classification of modern English/German sentences.
- 9. Constituents of a simple sentence in modern English/German.
- 10. Sentence pragmatics in modern English/German. Stylistics of the modern English/German language

### Stylistics of the English/German language

- 1. The subject of stylistics of the English/German language.
- 2. Concept of functional style and genre. Typology of functional styles and genres.
- 3. Classification of functional styles of the English/German language.
- 4. The concept of expressive means and stylistic techniques. Trails. Figures of speech.
- 5. Stylistic differentiation of English/German lexical units.
- 6. Graphic stylistic resources of the modern English/German language.
- 7. Phonetic stylistic resources of the modern English/German language.
- 8. Lexical-semantic stylistic resources of the modern English/German language
- 9. Morphological stylistic resources of the modern English/German language.
- 10. Syntactic stylistic resources of the modern English/German language.

#### 3. Structure of examination tasks

The exam includes four questions:

- 1. On the lexicology of the modern English/German language
- 2. From the theoretical grammar of the modern English/German language
- 3. On the stylistics of the modern English/German language
- 4. Conversation on the topic of the planned scientific research

When answering questions, applicants must demonstrate knowledge of unique literature (see the list of mandatory and additional literature), the ability to critically

consider existing views and clearly and reasonably formulate their position. Knowledge and correct use of professional terminology, mastery of linguistic analysis methods, and ability to illustrate theoretical positions with examples from the English/German language are required.

#### 4. Criteria for evaluating answers

Oral control of the written answer is carried out according to the degree of completeness and correctness of the answers to the questions on the examination ticket. The following criteria are taken into account:

- characteristics of the answer: elementary, fragmentary, complete, logical, evidential, substantiated, creative;
- quality of knowledge: correctness, completeness, meaningfulness, depth, systematic, generalization;
- level of mastery of research operations: the ability to analyze, synthesize, compare, abstract, generalize, and draw conclusions;
- experience in creative activity: the ability to identify problems, formulate hypotheses and the logic of their verification, and justify conclusions.

According to the evaluation criteria, each applicant's answer is evaluated on a 12-point scale (table 1). The overall score for the speciality interview is calculated as the arithmetic mean of all scores for each question.

The obtained points for the interview are converted into a 200-point scale according to Table 2.

Applicants who scored less than 100 points are not allowed to further participate in the competitive levels of educational achievements selection, and according to the exam results, they are given a "failure".
